**CBHCCF Foundation Donations Report of Donations and Financial Statements** Chief Financial Officer Rhoads provided an overview of donations, totaling \$266,841, received by the Foundation through June 22, 2016 and received since the Board's last meeting on December 7, 2015. Donations were designated as follows: \$192,440 for the Beverly Hills Community Dog Park; \$63,401 for Beverly Gardens Park Renovation Project; \$6,000 for the History of Beverly Hills Program; and \$5,000 for the Adopt a Park Bench Recognition Plaque program.

- 2) Donation Pledges for Beverly Gardens Park Renovation Project Community Services Administrator Grable reviewed current donation pledges to date for the Beverly Gardens Park fundraising efforts, with \$3.1 million total pledges; \$1.6 million received to date and \$1.5 million remaining.
- Policy Recommendations from the Charitable Solicitation Commission
  Charitable Solicitations Commissioner Karen Kay Platt reviewed the CSC's approval to exempt the Foundation from obtaining charitable solicitations permits and revising the City's Ordinance. In addition, she further emphasized the CSC's recommendation of "best practices" which included that all fundraisers should strive to obtain net proceeds greater than 50% of total contributions per event. Commissioner Platt indicated that the CBHCCF (or a CBHCCF representative) should review the expenses, project costs and financials of fundraisers seeking to utilize the CBHCCF's designation.
- 4) Current City Related Fundraising Efforts Utilizing the CBHCCF's Name
  Community Services Administrator Gisele Grable and Management Analyst Stephanie
  Harris provided updates regarding current and upcoming fundraising activities related to
  the Beverly Hills Community Dog Park Project, Beverly Hills Gardens Park Project and
  the Adopt a Park Bench program.

Board Member Rothner provided information regarding the Recreation & Parks Commission's recent decision to update the Park Bench Donation Program (City Dog Park benches include a \$5,000 donation; in perpetuity), and other city parks now include 2 options: \$5,000 for 10 years or \$10,000 for "in perpetuity"). The Board asked that when the item goes to City Council for approval that it include a recommendation from the CBHCCF and consider consistency in cost and term limits, changing "in perpetuity" to a definite time period (i.e. life of the bench/ approximately 25 years).

The Board agreed and approved the following recommendation: that the City's donation program for plaques on park benches be consistent citywide for the length of time (life of bench, not "in perpetuity") and cost for donations (one option and not two).
